TERMS & CONDITIONS

In the following conditions of contract, “the contract” shall mean the DL Photography Wedding Questionnaire, “Dominic Lowther” shall mean Dominic Lowther trading as DL Photography and “the client” shall be those whose name appears on the contract. The following terms of agreement form the integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by both Dominic Lowther and the client, in writing or email.

Booking Deposit

A deposit of 25% of the total coverage fee is required at the time of booking, together with the signed contract and is non-refundable or transferable in the event of cancellation. Dates are reserved only when this deposit is paid either by cash, cheque or electronic transfer. Please make cheques payable to DL Photography and bank details are available on request.

Balance Payment

A payment of the balance is to be made no later than one month prior to the wedding ceremony either by cash, cheque or electronic transfer.

Creative License

Dominic Lowther shall be granted creative and artistic license in relation to the choice of locations and poses used. Dominic Lowther’s judgment on photographic style and the number of photographs taken shall be deemed correct. Due to changes of weather and availability and willingness of subjects, Dominic Lowther will do his best to honour requested photographs but does not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement.

Colour Match

It is sometimes impossible to record on camera the exact colour of materials as perceived by the human eye. When processing images, the photographer will endeavour to achieve a pleasing overall colour balance. Some colours may not remain consistent throughout a set of photographs owing to variations in lighting conditions. Photographic printing is undertaken within the technical limitations of the process and colour may not be identical over the whole range within a subject. The colour balance of prints made at different times or in varying sizes may also be variable.

Display

The client gives their consent to Dominic Lowther the use of any images included in this contract to generally promote the business by means of websites, portfolios, advertising, publicity material, display areas, exhibitions, competitions, magazine articles and other such media.

Copyright

The 1998 Copyright Act assigns copyright to Dominic Lowther, which means the client may not copy the photographs taken under this contract, or allow copies to be made by any means except without prior and written consent from Dominic Lowther. The disc supplied to wedding clients containing their photographs will be clearly marked giving consent.

Force Majeure

Whilst every care is taken, this contract is subject to alteration or cancellation by Dominic Lowther owing to any cause/s beyond his reasonable control by third parties, Acts of God, Fire, War, etc.

Limitations of Liability

In the unlikely event of a total photographic failure or cancellation of this contract by either party or in any other circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.

Cancellation

If Dominic Lowther has to cancel this contract for reasons beyond his control, (death, injury, sickness etc.) his liability shall be limited to a full refund of all monies paid by the client. The client may cancel this contract at any time by giving written notice to Dominic Lowther. If the client should have to cancel a booking the following cancellation fees will become due immediately:

- The booking deposit is non-refundable after signing the contract.

- Cancellations made within two months of the wedding incur the full cost of the coverage option booked.

Should the cancelled wedding turn out to be a postponement, then, subject to availability, all money paid may be applied to the new wedding. In this case, the total fee chargeable shall be the fee that applies at that later time.
