WEDDING PHOTOGRAPHY TERMS AND CONDITION

1. It is agreed that the terms set out in this booking form is the total agreement made between the parties and that no variation or modification of this contract shall be effective unless agreed by both parties in writing.

2. Special Requests/Coverage

The client understands and accepts that the photographic coverage will be as the photographer's professional expertise determines and that no one photograph will be deemed more important than another. Special requests are not binding instruction, although every effort is made to comply with the client's wishes. Any special requests not notified on this booking form must be made by the client to the photographer/s in writing.

4. The Photographer

On occasions and without notice it may be necessary for the photographer originally specified to be substituted by another photographer, (e.g. due to ill health).

5. Images

All image sizes are nominal. The photographer/s will provide a pleasing colour balance but cannot guarantee exact colour matching owing to anomalous reflectance caused by a combination of certain dyes and materials especially man-made fibres. It is sometimes impossible to record on film/digital the exact colour as seen by the human eye.

6. Retouching

The photographer will perform a standard amount of retouching to take the photographs to a quality of which he is proud. Further retouching, digital manipulation and artist finishing is available to the client as an optional extra.

7. Copyright

Any images or copies of images whether stored digitally or otherwise and any computer program including any source or object code, computer files or printed documentation relating to such images are protected by the Copyright and Design Act 1988. It is contrary to the Act to copy or allow to be copied photographically/electronically or by any other means an image created as part of this contract without the permission of the photographer/s in writing.

8. Negatives/Digital Files

Negatives/digital files remain the property of the photographer/s.

9. Licence

The photographer/s shall be granted complete artistic licence including in relation to the poses photographed and the locations used. The photographer/s' judgement regarding the locations/poses and number of images taken shall be final. Due to the vagaries of the weather and the willingness of subjects it may not be possible to capture all the images requested.

10. Force Majeure or Act of God

The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control.

11. Previews

Although the photographer will do their best to produce more proofs/preview images than as discussed with the client, there is no guarantee that any particular number of proofs/preview images will be produced. Proofs can take up to four weeks to produce. You will be notified of any delay past this.

12. Album Orders

If you have an Album in your package are required to choose your photos for your Album order within four weeks of receiving the proofs. A late charge of £50 will be applied and a delay of your Album design may occur if ordered late. Generally you should expect up to four weeks to see a design preview of a GraphiStudio & Contemporary Matted/Flushed Album. This can be longer at times at peak or busy periods. You are responsible to proof any spellings in the Album design. We will require by writing either by email or letter to proceed with printing of the Album. If any spellings are incorrect after your proceed to print we cannot be held responsible for any re-printing costs for corrections occurred (this is payable by the client). After you have proofed this Album you should expect anything from four weeks up to eight weeks for this Album to be printed and delivered back to our Studio. Unfortunately we have no control over the timescale of printing of the Album. If you have a CD/DVD of Hi Res images or Complimentary item as part of package this is delivered with the Album as a complete package. These items will not be delivered or given separately. This is to ensure orders are complete.

13. Display

The client hereby allows the photographer/s to display any images included in this contract in their studios, portfolios, literature, wedding, exhibitions and advertising. No other use of the images will be made by the photographer/s for other commercial reason except with the written permission of the client.

14. Cancellation

The client may cancel this contract at any time by giving written notice to the photographer/s but in doing so shall forfeit any monies paid. Should cancellation be received by the photographer/s less than 30 days prior to the date of the ceremony. The booking Fee is non-refundable.

15. Refreshments & Meals

If Photographer or Photographers are booked after the Wedding Breakfast a Meal and Refreshment's must be provided for the Photographer(s).

16. Limitation of Liability

In the unlikely event of a total photographic failure or cancellation of this contract by either party or in any other circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.

17. Complaints

Any complaints should be raised by the client with the photographer/s, in writing, within 28 days of first becoming aware of the matter to be complained of and in any event within 28 days of receipt of the images.

I have read this booking form and agree to abide by the terms of agreement set out in it. I understand that the terms of this agreement cannot be changed unless agreed by both parties in writing.
